Boulder Ridge Event Tent Update – It Is Now A Building

As we shared with you a couple of weeks ago, it looks like we have made real progress in our discussions with Rocke Garcia and the County on the Event Tent. Rocke has listened to our concerns and is proposing a building – a building that will shield us from the unwanted sound impact. We met with Rocke and the County at a neighborhood communications meeting on March 10th and followed up with Rocke in a separate meeting to confirm our understanding. As noted in our earlier email update on the 17th,



the proposed building is quite nice. Additionally important is that the windows do not open and the only doors that can be propped open during an event face the clubhouse, away from our neighborhood.

We have reviewed the California Environmental Quality Act (CEQA) documents that detail the restrictions to be placed on the facility and have given our input to the County. Most of our comments are clarifications, not major concerns. We want the rules to be very clear and have made suggested edits to that end. The original draft of the CEQA documents are posted on our website (www.almadengraystone.org).

The next step is a public hearing at the Planning Commission meeting scheduled for the afternoon of April 2. Once we get a finalized agenda with timing, we will notify you by email. So, bottom line, our proactive work looks to have paid off. Our ability to organize quickly, draft clear legal arguments and fund outside noise consultants to raise important questions made all the difference. Kudos to Julia Alloggiamento for all her hard work reviewing mountains of old documents and then crafting our legal arguments.



Hillside Improvement Project – Phase 2 Is Now Underway

Phase 1 was the construction of the wall to stabilize the hillside. Phase 2 is to improve the look of the hillside. After talking with a number of landscape contractors, they all pointed out the wonderful natural rock formations high up on the hillside – formations completely covered with brush and weeds. We have now uncovered those rock formations, cutting away huge amounts brush, and do they look great! No amount of money could ever duplicate that look. Wow, what we have been missing for years!

The next step of the project is to do landscape improvements on the lower portion of the hillside. Starting next week, our contractor will be adding a few new trees, building rock wells around the new and existing trees and doing some grading. The final step will be to re-seed the wildflowers in the late fall.

Also, thank to our neighbors the Naffa's @ 6570 Pfeiffer Ranch Road for allowing us to tap into their watering system to water the new trees. Your cooperation is much appreciated, by the new trees and us.
