

Councilmember Nancy Pyle Meeting Scheduled For March 5th Over the past few months we have all been worried about the potential for new homes being built on our much-appreciated open space. We engaged with Nancy Pyle's office (our District 10 Councilmember) and with the San Jose City Planning Department to fully understand the issues and our options. As we reported in our last newsletter, we have received good support from both offices. Many of you asked if you could meet with Nancy Pyle so you could personally express yourself and hear her position on further development/zoning changes. She welcomes the opportunity to meet with us. Both Nancy Pyle and her Chief of Staff, Lee Wilcox will meet with us on Monday, March 5th. We will meet at the Almaden Community Center on Camden Avenue, which is co-located in the new Almaden Library. The meeting will start at 8:00 PM. Light refreshments will be served. So please mark your calendars now. The room is large and we hope that we can show Nancy Pyle a great turnout!

In order to make the meeting as productive as possible, please email me questions/issues that you would like her to address so we can brief her ahead of time. She is anxious to be "fully responsive" to our questions and concerns and would like to do her homework prior to the meeting. I will be meeting with Lee Wilcox on February 28th to provide him with at least some of the topics we would like to cover. Retaining Wall Completed Under Budget

After more than a year in the planning, the retaining wall along Pfeiffer Ranch Road is now complete. Working through the financing questions, City approvals and permits and finally the insurance issues proved to be quite a challenge. But, we did it. Many of you have commented on how nice it looks. We agree. Not only did we complete the wall, we were able to add decorative rock in the park strip between the street and the sidewalk. And, we came in under budget by \$1,807. Our original budget was set at \$15,269 based upon contractor estimates. The final bill was \$13,462 with \$5,726 coming from the City of San Jose CAP award and the remainder from our dues. We set aside \$5,000 from our 2005 funds and paid the remainder out of 2006 funds.

We want to take this opportunity to thank Loayza's Landscaping for doing a great job. They completed the project on time, on budget and were a pleasure to work with. Additionally, they worked very effectively with the City on the insurance requirements - not an easy task.



Neighborhood Watch Alert

On December 22, 2006, a car was stolen from Pfeiffer Ranch Road. A holiday party was being held at the Shah home and a 1993 Voyager van which belonged to one of the guests of the party was stolen sometime between the hours of 8:30 p.m. and 11:00 p.m. The van's owner insists the van was locked. The van has since been recovered, however, it is still in police custody and the owner does

not know its condition or if any items in the van are still there.

Another incident occurred on January 4, 2007. A 1993 Acura Legend which was parked in the driveway of the Dietz home on Deer Hollow was broken into and vandalized. This occurred in the middle of the day (between 1:00 p.m. and 3:30 p.m.) The passenger side window was smashed and the built-in cell phone was removed. The car's battery was dead and the car was unable to start which may be the only reason it was not stolen.

Neighbors - Please be on the alert for suspicious looking characters in the neighborhood and please make sure you always lock your car and do not keep anything of value in it especially if it is visible through a window (i.e. a portable navigation system, cell phone, purse, etc.) These incidents show that no matter how wonderful the neighborhood is, bad things can still happen.
