Our preliminary analysis:

Many of you said the Association Board is on track and "doing a great job". It is always good to revisit if what we are working on is what is valuable to you. Five out of the six categories of services scored greater than 2.5 on a 3.0 scale. Based upon this feedback, we believe we are doing mostly the right things and will continue our direction.

Almost all of you see high value in our community action work, such as Boulder Ridge, common area maintenance and the special projects that we tackle on a periodic basis. These three areas also represent the largest expense areas with over 70% of our funds going to support these core services. Additionally, while a bit lower in value, the services such as dumpster day and our efforts in communications (website, directory & flyers) are solidly rated. Social activities got the lowest score and got the most 1's, for low value. Given the fairly modest attendance at events, this is not surprising. Seemingly, those that participate in events like them and rate them a 2 or a 3. Those that do not see much value, choose not to attend. Accordingly, we will keep our expenses for events modest.

In response to the survey, we will once again coordinate a garage sale, prior to dumpster day. See the article in this newsletter for details. The remaining suggestions will be discussed at our next Board meeting.

Communications of Association news will continue to be primarily "electronic", as electronic transfer was the big winner. Email, PDF newsletters and the website are far

out ahead of hardcopy and face-to-face meetings. Accordingly, we will continue our current efforts, only using hardcopy and meetings when they are absolutely necessary.

Finally, let's look at some of your comments. The problem of kids loitering, drinking and/or "doing drugs" in the open space is an issue. We have talked with the police and they request that we call 311 when we see a potential problem and ask for a dispatcher. The police will send a patrol car and ask the kids to leave. They are trespassing and are not allowed to congregate. They believe that if the trespassers are frequently asked to leave, they will find a new place to gather. It will be our win and somebody else's loss.

The other major issue seems to be that some homeowners are not keeping up their yards and houses. Some houses need painting and several yards are mostly dirt and/or overgrown. Not only are the properties unsightly, people worry that property values are negatively affected. In the past, we, the Board, have contacted the offenders and asked the owners to fix up their property. While we will still do this, we also ask you to talk with your neighbors. We will continue to look into enforcement options, but for now, we ask you to continue to seek change through encouragement and peer pressure.

Again, the Board will discuss all of your feedback at our upcoming meeting. Thanks for the input and the overall vote of confidence. We will report back.

Boulder Ridge Event Tent – Final Update

As we have noted in past communications, this was a big win for our neighborhood. Silence is golden! Our collective actions made the difference. In case your missed the article in the Almaden Resident, construction of the Event **Building** is expected to begin this summer. Rob Eastwood is quoted in the article as saying "The process worked. People actually clapped after the Planning Commission's decision." We agree! Now, the only issue seems to be compliance with the noise restrictions placed upon the facility. It will be our job to monitor noise and report any non-compliance. Loud music anytime or music after 10 pm is prohibited. The Planning Commission will monitor complaints and do their own periodic, unannounced, sound level checks.

We can make noise complaints from 9 am to 5 pm on weekdays by calling the Department of Environmental Health at 408 918 3400. Past 5 pm, we are asked to call the Santa Clara County Office of the Sheriff at 408 686 3650.

Once the building is operational, we will update everyone on the status and remind you of the numbers for noise complaints. Again, thanks for your support. It made a real

Then, probably next year given budget constraints, we hope to re-do the rocks between the sidewalk and the street. We plan to remove the old stones and replace them with larger stones like the ones in front of the wall on Pfeiffer Ranch and embed the larger stones in a thin layer of cement to permanently stop the weeds from coming back.
