Homeless Man Living Under The Bridge?

Over the past several months, many of you have expressed concerns about a homeless man living under the bridge on Graystone Lane by the creek. Concerns have included safety and welfare issues for the man, trail walkers and neighborhood children. Special thanks to Beth and Malcolm Bordelon for working hard to figure out what they could do to address this problem. It was hard for them to get anyone with authority to help.

Finally, we turned to Nancy Pyle's office to see if they could assist. Joseph Sanchez, Council Assistant to Nancy, has worked to help us navigate the issue and try to get some action. Initially, he referred our issue to the San Jose Police department. Their initial response is printed in full on the next page. Suffice it to say, budget cuts have reduced the police department's responsibility in this area as they now only respond to a crime in progress. We followed up with them to ask that they investigate if the individual is a registered sex offender or wanted by the authorities. The good news is that they did investigate and it seems to be that he is neither.

Finally, we are now working with the Santa Clara Valley Water District (SCVWD) to address this situation. As we get additional details, we will keep you posted.

Initial Police Response

Ms. Bordelon and Mr. Sherwood,

Councilwoman Pyle's office contacted me regarding the issue with the homeless man who has taken up residence under the bridge at Pfeiffer Ranch Road and Graystone Lane. I understand your concerns and am sorry for the frustrations you have encountered in determining the proper entity to whom you should report the problem. I know Councilwoman Pyle's office explained to you the Water District is responsible for this particular area, and we are no longer doing encampment clean-ups. As a result of staffing cutbacks and reconfigurations, it was necessary to move 35 officers from our Special Operations Division back to Patrol in order to maintain proper staffing levels to respond to calls for service. Unfortunately, this downsizing impacted the METRO Unit whose responsibilities included homeless encampment enforcement and clean-up. It is an assignment that cannot be done by uniformed patrol officers for a variety of reasons, not the least of which is the fact patrol officers lack the specialized training the METRO officers received specific to issues and laws applicable to the homeless (there are civil issues) and, obviously, not being in uniform and in an undercover capacity allowed the METRO officers to infiltrate the encampments and observe arrestable crimes outside of trespassing. Unfortunately, the homeless issue is a social issue we have grappled with for years in this city. There are a handful of shelters available for the homeless, however, many opt not to utilize them. And, quite frankly, some transients choose this lifestyle despite having other viable options. Suffice it to say, there are no clear cut answers for the service providers and first-responders that deal with the homeless on a daily basis.

As is the case in your neighborhood's complaint, many homeless encampments are on private property with the vast majority of them on Water District and railroad property, however, there are, also, a few on City-owned properties. We have worked with the City, the Water District and the railroad lines to provide trained officers in a secondary employment capacity to assist them in dealing with illegal encampment issues. All of this information is available on our PD website (sipd.org). If this encampment is in the creek area, you report it to the Santa Clara Valley Water District Water Shed Hotline at (408) 265-2600 Ext. 2378.

That being said, patrol officers will always respond when crimes in progress are occurring that are related to the encampments, and we will take appropriate action. It is important for the reporting parties to be specific about the crime occurring, such as fights, drinking in public, aggressive panhandling, etc., as opposed to merely telling the call taker that homeless people are living in a certain area. Specific to your situation, has this transient approached any citizens or done anything that would suggest he is confrontational or aggressive, or does he pretty much keep to himself? I know you said an officer has already spoken to him, so I would assume he has been identified and is not wanted or a 290 registrant. In any case, I will notify the district supervisor and insure officers contact this individual and confirm he is not wanted or a sex registrant, and I will let you know the outcome of that contact.

I know this is not necessarily what you want to hear, but, hopefully, I have explained the circumstances--trust me when I say, the fact we have 100 less officers on our Department than we did this same time last year has affected our response to several lower priority but quality of life type calls for service such as what your neighborhood is facing. But, hopefully, I have cleared up the issue regarding whom to contact to report the homeless encampment. I concur wholeheartedly with Officer Garrison regarding the number of people that report the situation to the Water District makes a difference in response--as they say, "squeaky wheel gets the grease." Stress the fact it is in the middle of a residential neighborhood near a playground. In the meantime, keep an eye out, and don't hesitate to call if you believe he is committing any type of crime outside of the trespass situation. And, feel free to call me if you have any questions or wish to discuss or clarify any of the above information.




